This has reference to your application dated 31st
October, 2002, for affiliation of a new college of Education
proposed to be started at Sanpada, Navi Mumbai, from the
academic year 2003-04.

In this connection, I am directed to inform you that
considering the permission granted by the Government of
Maharashtra to your society as per the letters referred
above, the Vice-Chancellor under the powers conferred upon
him under Section 14(7) of the Maharashtra Universities Act,
1994 as amended by the Maharashtra Universities (Amendment
and Continuance) Act, 2000 has granted the permission for
first time affiliation to your society to open a new college
of Education at Sanpada, Navi Mumbai on 'Permanently No Grant
Basis' from the academic year 2003-04 to start the B.Ed.
Degree Course with intake capacity of 100 students.

The college has to fulfill the conditions mentioned in
the letter No.WRC/2-32/2003/2303, dated 12th May, 2003
issued by the Regional Director, National Council for
Teacher Education, Bhopal.

The college has also to fulfill the following
affiliation conditions -

(1) that the conditions laid down by the University from
time to time.

(2) that the minimum attendance of all the students
not be less than 75% during the academic year.


